A BILL

To make certain individuals ineligible to receive any Federal
financial aid under title IV of the Higher Education
Act of 1965.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Freeze Aid For Stu-
5 dent Assaulters Act of 2024” or as the “FAFSA Act of
6 2024”.

1 **SEC. 2. IN GENERAL.**

2 (a) **TERMINATION OF ELIGIBILITY FOR TITLE IV AS-**
3 **SISTANCE.**—Beginning with the first award year that be-
4 gins after the date of the enactment of the Freeze Aid
5 For Student Assaulters Act of 2024, an individual shall
6 not be eligible to receive any grant, loan (other than a
7 loan described in subsection (b)), or work assistance under
8 title IV of the Higher Education Act of 1965 (20 U.S.C.
9 1070 et seq.) and shall repay, in accordance with sub-
10 section (b), the sum of the amounts of any grant received
11 under such title, if the individual has been convicted of
12 a criminal offense—

13 (1) of assault against a police officer; or

14 (2) of rioting, the elements of which may in-
15 clude—

16 (A) inciting a riot;

17 (B) organizing, promoting, encouraging,
18 participating in, or carrying on a riot;

19 (C) committing any act of violence in fur-
20 therance of a riot; or

21 (D) aiding or abetting any person in incit-
22 ing or participating in or carrying on a riot or
23 committing any act of violence in furtherance of
24 a riot.

25 (b) **CONVERSION OF GRANTS TO LOANS.**—

1 (1) IN GENERAL.—If an individual who is sub-
2 ject to the termination of eligibility described in sub-
3 section (a) has received any grants under title IV of
4 the Higher Education Act of 1965 (20 U.S.C. 1070
5 et seq.) for a program of study in which the indi-
6 vidual is enrolled as of the date on which the crimi-
7 nal offense occurred, such grant shall be treated as
8 a Federal Direct Unsubsidized Stafford Loan under
9 part D of such title, and shall be subject to repay-
10 ment, together with interest thereon accruing from
11 the date of the grant award.

12 (2) NO REPAYMENT ASSISTANCE.—Such loans
13 may not be eligible for any loan forgiveness, can-
14 cellation, discharge, or reduction programs under the
15 Higher Education Act of 1965 (20 U.S.C. 1001 et
16 seq.), any other provision of law, or any administra-
17 tive action or program.
